

Job Description Swimming Instructor

Purpose of Job:

To deliver lessons which motivate, educate and encourage children of varying abilities

Qualifications required: Current ASA/STA Level 2

ASA/STA Level 2 Award in Safety for Teachers Rescue Test or National Pool Lifeguard Qualification

Reporting to: The PE Sports Leader

Key Responsibilities

- Plan and deliver lessons to a high standard, including for pupils with special educational needs and disabilities
- For the duration of the lesson to instruct, provide explanations and demonstrate swimming techniques, correct faults in swimming techniques and identify ways to improve performance
- Teach booster groups before school?
- Train the school swimming team to participate in the Borough Swimming Gala
- Teach with full regard to health and safety regulations, including the safe provision of all equipment and ensuring it is used correctly; operating within Health & Safety guidelines; and undertaking risk assessments.
- Carry out Fire Evacuation Training with the children when required.
- Be a positive role model, creating a positive and fun environment in which to motivate and encourage children to participate in swimming, welcoming all participants in a professional and friendly manner.
- Follow the school behaviour policy and ensure that high standards of behaviours are maintained in all sessions.
- Identify participants' abilities and encourage them to reach their full potential, planning and delivering sessions appropriate to the level of swimmer.
- Log and report any incidents/accidents or any other concerns to the Headteacher or Deputy Headteachers
- Attend regular training
- Liaise with PE/Sports Leader on pupils' progress.
- Assess new pupils as required
- To constantly update, manage and complete registers
- Complete Assessments of children's progress
- Report any safety concerns or health and safety issues to the Site Management Team and Headteacher.
- Produce yearly progress reports for each child.
- To be aware of Child Protection issues, identifying and monitoring suspected child abuse and children at risk, reporting to the designated safeguarding lead.

General Duties

- To arrive in good time before the lesson start time, to ensure facilities are set up appropriately and to leave the pool in a clean and tidy state at the end of each session.
- Present and conduct yourself in an appropriate manner with courtesy and regard for others.
- Wear suitable clothing for teaching when in and out of the water, and when leaving or arriving on site.
- Attend progress and award meetings.
- Maintain your qualifications, ensuring they are up to date and relevant.
- To follow all school policies and procedures

- ASA or STA level 2 teaching
- Current Rescue Test or National Pool Lifeguard Qualification
- The ability to effectively deliver high quality swimming lessons to pupils of all ages and abilities with minimal supervision.
- The ability to inspire confidence and motivate swimmers
- The ability to deal with pupils and their queries and concerns with tact and sensitivity.
- The ability to encourage pupils with the appropriate use of praise and put them at ease
- The ability to work as part of a team.
- The ability to work under pressure.
- Good written and verbal communication skills.
- STA Level 2 Certificate in Aquatic Teaching Special Needs would be an advantage or willingness to undertake training

Knowledge and Understanding

- Good understanding of the characteristics and qualities of high quality swimming lessons.
- An understanding of how to differentiate in a coaching session
- Knowledge of Health and Safety legislation and other legislation in relation to pool operations.
- Understanding of Child Protection Policy and Equal Opportunities Policy
- Knowledge of the National Plan for Teaching Swimming.
- Knowledge of the ASA / STA Award system.

Experience

- Experience of teaching pupils in groups of mixed ability and age.
- Experience of teaching all spectrums of the curriculum.
- At least 5 years' teaching experience.
- Evidence of achieving results and making a difference to pupils.
- Experience of teaching pupils with special educational needs and disabilities.

Personal Qualities

- Enthusiastic and positive attitude towards swimming
- Approachable yet firm.
- Pleasant, friendly and outgoing manner.
- Persevering and patient
- Reliable and committed.
- Demonstrates trust, openness and respect in dealings with people.
